

# 2011/2012 CAROLINA DANCE CAPITAL COMPETITION COMPANY ENROLLMENT AND POLICIES INFORMATION

**\*Please read the following very carefully and make sure you understand each policy so that there are no misunderstandings.**

1. Please arrive for classes on time. Tardiness is a distraction.
2. Hair must be secured off the face and neck with hairspray or gel in a ponytail or bun. A classic bun must be worn in all Ballet classes for competition students along with pink tights and a black leotard.
3. Students should always be friendly, courteous and respectful of the teachers and other students.
4. There is always a **\$35.00 return check fee. After two returned checks, we will accept cash or credit card payments only.**
5. **Tuition is due at the first of each month! After the 10<sup>th</sup> of each month there will be a \$10.00 late fee.** At the end of every month your account should reflect a \$0.00 balance. The only thing you should owe is whatever fees are due for the next month. All accounts will be charged a **\$20.00 late fee** if a balance is carried over to the next month. Tuition will not be prorated or refunded.
6. Please keep our studio clean. **No eating or drinking is permitted except in the student lounge.** We do expect students and parents to clean up after themselves.
7. Competition students **MUST** call the office in the event of an absence.
8. Recital fee of \$65.00 is due by January 1, 2012. **Recital fees are non-refundable!**
9. **Competition costume deposits are non-refundable!** Sewing will not be completed on any costumes with outstanding deposits.
10. **Competition entry fees will have to be paid by the due dates!** Your child will not be entered in the competition until their entry fees are paid.
11. **All accounts must be paid in full before your child can compete at the 2012 Nationals.**
12. **Yearly competition tuition is based on our 11 months dance program.** Tuition is based on classes offered, extra rehearsals, reveals, as well as taking into consideration studio closings, holidays, summer breaks before and/or after Nationals. **The yearly tuition can be paid in 11 monthly installments (Sept.'11 - July '12) as a convenience to you. Your last payment therefore does not necessarily cover a full month of classes in July, as it is merely your last payment for the dance year.** A 10% discount will be given towards tuition when it is paid for the entire year by check or cash – no credit card (expires September 1, 2011). August tuition is NOT included, as this is considered our audition month, and tuition varies depending on classes taken during that month.
